Under the KiwiSaver Act 2006, you may be able to transfer your KiwiSaver account balance to a participating Australian complying superannuation scheme if you have permanently emigrated to Australia. The transfer of your savings from the GoalsGetter KiwiSaver Scheme to a participating Australian complying superannuation scheme is subject to the Manager's approval and the Australian complying superannuation scheme accepting your transfer.

Subject to approval, the total value of your KiwiSaver savings must be transferred to your nominated participating Australian complying superannuation scheme up to the maximum amount permitted under Australian legislation (currently \$AUD 450,000). You can apply to transfer your KiwiSaver savings at any time after you have permanently emigrated to Australia. Any government contributions received by you after you left New Zealand will be returned to the government.

Transferring your GoalsGetter KiwiSaver Scheme account balance to a participating Australian complying superannuation scheme may have tax and other financial implications. You should seek independent tax advice and financial advice before transferring your GoalsGetter KiwiSaver Scheme account balance to an Australian complying superannuation scheme.

#### 4. Identification and Proof of Address

As part of your application, you must provide copies of your ID and proof of address.

Please provide us with either:

- a copy of your current passport (page showing your name, date of birth, photograph and signature), or-a copy of your current driver licence showing your name, signature and expiry date, AND a bank account statement or document that contains your full name and addressed to you by a New Zealand registered bank within the last 3 months, or statement from any New Zealand government department addressed to you dated within the last 3 months, or New Zealand SuperGold card, or birth certificate, or
- a copy of your current firearms licence.

AND one of the following issued and dated within the last 3 months, showing your name and current residential address:

- Bank statement
- Utility bill (e.g. power or home phone bill)
- Rates bill
- Letter or statement from a government agency

## Who can certify your documents?

If you are overseas, your documents must be certified by a person authorised by law in that country to take statutory declarations or equivalent in the country you are applying from. Your certifier must state what authorises them to be able to certify these documents e.g. NR stamp, CA stamp etc.

The following people can certify photocopies of original documents as true and correct copies:

- Notary Public
- Justice of the Peace
- A person who has legal authority to take statutory declarations (or equivalent) in Australia.

Please note that the certifier must be at least 16 years of age and cannot be:

- a person involved in the transaction requiring the certification
- related to you
- your spouse or partner
- a person who lives at the same address as you.

Copies of ID and proof of address must be recently certified (in the previous three months) as a true copy of the original which represents your identity by one of the people listed above.

# 5. Agreement and Statutory Declaration

A statutory declaration is a written statement that allows a person to declare something to be true. You'll need to complete this page including signing it, in front of an authorised person. You'll make the declaration, and the person witnessing will take the declaration.

### Who can witness the declaration?
