Investing on behalf of a minor

To open an investment account for children under 18 years old, we'll need to verify their identity, confirm their address and in all instances, you will need to provide additional documents for yourself as the parent(s) or guardian(s) of the child.

- For applicants under 16, both of the applicants parents or legal guardians must sign this form
- For applicants 16 or 17, one of the applicants parents or legal guardians must also sign the form

What happens when the Minor turns 18 years old?

When the Minor turns 18 years old:

- They remain the legal owner of the account.
- They will now have sole and full authority over the account, including making transfers, fund switches and withdrawal decisions (noting that the Investment withdrawal restrictions will still apply).
- For the parent(s)/guardian(s) any authority over the account ceases at this time, unless we receive evidence of enduring power of attorney. Parent/Guardian's access to view that particular account in GoalsGetter will be removed.

We will email the parent/guardian to request that updated contact details and current identity documentation be provided by the Minor to us. We will then open a new GoalsGetter account for the Minor so they can see their investment online.

Who can certify your documents?

The following people can certify photocopies of original documents as true and correct copies:

- Notary Public

Please note that the certifier must be at least 16 years of age and cannot be:

- a person involved in the transaction requiring the certification related to you your spouse or partner
- a person who lives at the same address as you.

Copies of ID and proof of address must be recently certified (in the previous three months) as a true copy of the original which represents your identity by one of the people listed above.
